


Choosing the right education and training partners

- 2. Competence of REG providers min. 1 person with CCT Level C or similar requirements** working for the applicant

- * content will be assessed in a way that each competence/key competence indicator included will have to be covered with at least 2 hours of direct physical or digital attendance
- ** min. 6 months of experience with min. of 500 working hours in project management training activities (within the last 3 years)
